The meeting was started with recitation of few verses from Holy Quran.

Director Exploration delivered the detailed briefing to chair and all the attendees. After the briefing the chair invited all the participants to open discussion.

The legality & issues regarding the blocks in light of current law (i.e. Mineral Sector Governance Act-2017) was explained in detail by the Director Licensing. The members from academia inquired about all data on hand. The members were informed that DGMM have only stream sediment analysis data that was handed over to this department by then SDA. The data was collected under AustAid funded project. Later on same was further studied with consultant provided by world bank and these blocks were delineated after analysis of the available data.

Members from academia showed their concern regarding scarcity of data for even proposing the block for exploration. The members were informed that as these has been already showcased via print media in 2015, so now it's not possible to drop these blocks from consideration.

Members from Board of Investment (Federal & Provincial) also added that whenever they showcase these blocks, the interested investor demands some tangible pre-feasibility / feasibility report to study the potential of areas/blocks.

Members from academia afford a helping hand, free of cost to up grad the available reports and to put in some latest information that can be acquired through remote sensing and with the help of some new technological approaches. In order to make the reports more valuable and up to the standard of age. Auction of Placer Gold Blocks were also come in detail discussion and points of focus were to fix the reserve price and acreage for each block, already delineated by the department. In response to it, the Academia raised that, first they will look to the reports (already provided by National Centre of Excellence in Geology (NCEG)) in detail and then will be in position to fix any reserve price and feasible acreage for each block.

It was decided that DGMM will provide all available record to academia/ members, so that toP have a tangible informative feasibility report. Alongside with this all members will also give their views/ comments on the shared ToR's before next meeting is called. The meeting was ended with vote of thanks from and to the chair.
