No.PA/ Khyber Pakhtunkhwa/Bills/2012/21229.— The Khyber Pakhtunkhwa Universities Bill, 2012 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 11th May, 2012 and assented to by the Governor of the Khyber Pakhtunkhwa on 17th May, 2012 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA UNIVERSITIES ACT, 2012 (KHYBER PAKHTUNKHWA ACT NO. X OF 2012)

(first published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa (Extraordinary), dated the 18th May, 2012)

AN ACT

to reconstitute and reorganize the Universities established or to be established by the Government of the Khyber Pakhtunkhwa.

WHEREAS it is expedient to reconstitute and reorganize the Universities established or to be established by the Government of the Khyber Pakhtunkhwa to further improve their governance and management by ensuring accountability, transparency and giving due representation to all stakeholders in decision making, so as to enhance the quality of higher education in the Province of the Khyber Pakhtunkhwa.

It is hereby enacted as follows:

CHAPTER -I PRELIMINARY

1. Short title, application and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Universities Act, 2012.

(2) The provisions of this Act shall come into force with respect to the Universities listed in the Schedule on such date as may be specified by Government by notifications published in the official Gazette as the date of repeal of the Act or Ordinance constituting each of the University specified in the Schedule.

to amend the Khyber Pakhtunkhwa
Universities Act, 2012.

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Universities (Amendment) Act, 2012.

(2) It shall come into force at once.

2. Amendment of section 3 of the Khyber Pakhtunkhwa Act No. X of 2012.---In the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012), hereinafter referred to as the said Act, in section 3, in sub-section (2), the full-stop at the end shall be replaced by colon and thereafter the following proviso shall be added, namely:

“Provided that the Government may set up a University in place of campus or sub-campus of any University listed in the Schedule and transfer all assets, liabilities, employees and students of such campus or sub-campus to such University.”.

3. Amendment in the Schedule to the Khyber Pakhtunkhwa Act No. X of 2012.---In the said Act in the Schedule,-

(i) against serial No. 2, the words “Khyber Pakhtunkhwa” shall be deleted;

(ii) against serial No. 3, for the existing entry, the following shall be substituted, namely:

“The University of Agriculture, Peshawar.”; and

(iii) after serial No. 12, the following new entry shall be added, namely:

“13. The Khushal Khan Khattak University, Karak.”.

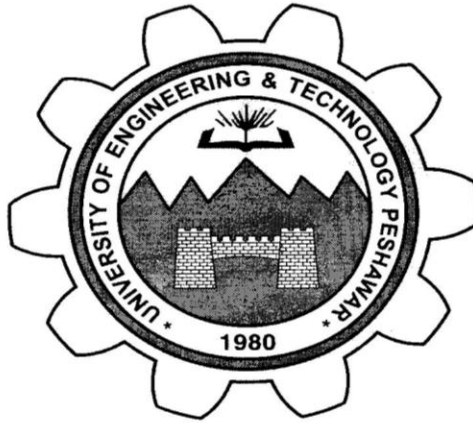
