- All members of the committee will ensure participation in the meeting without failure on the Date, Time and Venue fixed for the Works Committee meeting. However, in case of unavoidable circumstances any or few members could not participated in the meeting, then 2/3rd of the participation will be ensured for the proceedings otherwise, the meeting shall be deferred and date shall be announced for next meeting.
- The Committee will reconcile Terms, Conditions for procurement and services etc in line with the Tender Notice and KPPRA Rules (2014) for main Campus as well as other satellite campuses works.
- The Works Committee will constitute a Technical Committee to examine the cost estimates, specifications, rates for any sort of work in main campus as well as in other campuses of UET.
- The Works Committee will be empowered to inspect the Civil Works on case to case basis on completion.
- Final bill of the works shall be cleared subject to concurrence of Works Committee.
- Major changes if any in the approved scope of works shall be placed before the Works Committee for information, perusal and sum up recommendation for approval of the competent authority.
