The Superintendent Examination Center will have full authority to expel a student from the Examination Hall if found guilty under the Rules, laid down hereunder:

Following penalties are laid down for the given offences committed by the candidates during the course of and examination.

4.	Refusal to hand over the cheating/ objectionsable material in possession/ to the supervisory staff.	Expulsion from the Examination Hall/cancellation of Examination and/or debarring upto a maximum of three subsequent examinations.	Superintendent/University Discipline Committee.
5.	Use of violent or abusive language/ misbehaviour with Supervisory Staff/ Disobedience of lawful orders of the Supervisory Staff/ threats to Supervisory Staff.	Expulsion from the Examination Hall/cancellation of Examination and/or debarring upto a maximum of five subsequent examinations/Rustication from the University (with the approval of the Vice. Chancellor).	
6.	Smuggling of Script/Sheets/Question Paper out of/into the Examination Hall.	Cancellation of Examination and/or debarring upto a maximum of five subsequent examinations.	University Discipline Committee.
7.	Impersonating or causing to imimpersonate in the Examination Hall. Causing disturbance in the Examination	Cancellation of Examination and/or debarring upto a maximum of five subsequent examinations. The person involved in impresonating may be handed over to the Police by the University Authorities.	Superintendent/University Discipline Committee.
8.	Causing disturbance in the Examination Hall.	Expulsion from the Examination Hall/Cancenllation of Examination and/or debarring upto a maximum of five subsequent examinations.	Superintendent/University Discipline Committee.
9.	Inciting the candidates for walk out.	Expulsion from the Examination Hall/Cancellation of Examination and/or debarring upto maximum of five subsequent examinations/reustication from the University (with the approval of the Vice. Chancellor).	Superintendent/University Discipline Committee.
	Tearing of the Answer Book/Question Paper in the Examination Hall.	Expulsion from the Examination Hall/Cancellation of Examination and/or debarring upto maximum of three subsequent examination.	Superintendent/University Discipline Committee.
	Disclosing Identity or making particular marks/Appeals in the Answer Book.	Cancellation of the paper concerned.	University Discipline committee (on the report of the Examiner or any official

Any other offence committed by a candidate or any other student which is not covered by the above Rules, reported by Superintendent or any other official on duty, would be dealt with under the University Discipline Rules, according to the magnitude of the offence. In case of tie the decision of the Chairman of the Committee in consultation with the Vice-Chancellor, will be final.
