	, now therefore, in consideration of the study leave (with pay) the
SCI	HOLAR agrees and undertakes as under:-
1.	The SCHOLAR shall not extend the specified period of studies without the prior approval of UET Peshawar.
•	The study leave (with pay) shall be initially valid for one year and may be renewed/extended up to a maximum duration of years towards degree (course of study), subject to the satisfactory performance of the employee. The SCHOLAR shall not change the specified course of studies in the assigned field, and shall not register in a course of study other than that specified in the letter of award without prior approval of the UET Peshawar.
4.	Change of University/Institution during the course of study shall be admissible only with the prior approval of the UET Peshawar.
5.	The SCHOLAR will be bound to seek an NOC about issuance/renewal/period of validity etc. of passport from the UET Peshawar. In case of any breach, the UET Peshawar shall have the right to pursue the blockage of CNICs and passports of such employee/scholar and his/ her Guarantor with the immigration/passport authorities.
6.	The SCHOLAR shall fully obey the national and local laws of
7.	The SCHOLAR shall not enroll or register in another degree program after the completion of Ph.D. studies for which the study leave (with pay) was granted.
8.	The SCHOLAR shall return to Pakistan immediately after completing all the requirements of the Ph.D. program and report to the UET Peshawar in person along with required documents in respect of completion of course of study.
9.	The payment of allowances admissible under the study leave shall be made subject to the complete adherence to all rules and regulations governing the scholarship, as well as

satisfactory performance in the authorized studies.

- The SCHOLAR shall refrain from engaging in any political, commercial or any other activity incompatible with his/her program of studies abroad.
- 11. The SCHOLAR shall not undertake any employment, whether paid or otherwise, without the approval of the UNIVERSITY during the course of studies aboard.
- 12. The SCHOLAR shall not incur any debts during his/her stay abroad, and shall clear all outstanding bill/dues before leaving the country of studies/training.
- 13. In case the SCHOLAR fails to qualify the course for which this study leave is awarded, the UNIVERSITY reserves the right to recover the entire expenditure, inclusive of travel cost, from the EMPLOYEE/GUARANTOR, in addition to liquidated damages and conversion of study leave availed by him/her into other leave standing to his credit or into extraordinary leave without pay.
- 14. The SCHOLAR will be liable to disciplinary action as under:-
- a) If the SCHOLAR fails to comply with the instructions of the UNIVERSITY for proceeding abroad without any cogent reasons acceptable to the UNIVERSITY, he/she will be liable to reimburse the UNIVERSITY, on demand, the amount of passage money spent in connection with his/her scheduled study leave.
- b) If the SCHOLAR violates any condition laid down in this Deed of Agreement, he/she shall be liable to the penalties prescribed therein.
- 15. Upon the return, the SCHOLAR shall be bound to serve the UNIVERSITY for a period of <u>5 years</u>. This bond-period shall commence from the date the SCHOLAR rejoins his/her duties in the UNIVERSITY along with official documentary proof stating the completion of all requirements of the PhD degree (otherwise the bonded period will be counted from the date when EMPLOYEE submits his/her degree), on his/her position.
- 16. THE SCHOLAR COVENANTS, that in case of breach of any of the above terms and conditions and/or his/her failure to return to the UNIVERSITY within the specified period, and failure to serve the UNIVERSITY for the specified Bond period, he/she binds himself/herself firmly to pay on demand the liquidation damages of Rs. 1 Million along with the payments made to the SCHOLAR admissible under the study leave (with pay).

The SCHOLAR must produce two guarantors (hereinafter called the SURETIES) who shall be either Government servants in BPS-17 or above serving in University of Engineering and Technology, Peshawar on regular basis with confirmed status or persons of means, acceptable to the UNIVERSITY.

- 17. The SURETIES shall be equally bound by the Deed of Agreement and must guarantee that the SCHOLAR shall executes the contract faithfully, and in case of failure, the SURETIES shall indemnify and pay to the UNIVERSITY all monies and penalties mentioned in the paras above.
- 18. Upon his/her return from study leave, the SCHOLAR shall have no right to claim higher pay or seniority over others on account of the said study, further he/she shall have no right to claim for conversion of his study leave to any other leave.
- 19. The SCHOLAR shall be granted normal, and special, increments on rejoining the UNIVERSITY as admissible under the rules.
