On the recommendations of the Syndicate made in its 137th meeting held on June 22nd 2025, the Senate in its 15th meeting held on July 16th 2025 approved the Revised Estimates (Actual) for FY 2024-25 with an outlay i.e. total available resource of Rs. 2,891.896 million and total expenditures of Rs. 3,174.460 million, with a deficit of Rs. 282.564 million, leaving behind a cumulative deficit of Rs.1,366.615 million. The Senate also approved the Proposed Budget Estimates 2025-26 with the following outlay, (as per attached Summarized Budget Profile).

Total Available Resources	Rs. 3,247.725 million
Total Expenditures	Rs. 3,274.223 million
Deficit	Rs. 26.498 million
Total Deficit	Rs. 1393.113 million

The following conditions were set to be fulfilled in this regard:

- i. Out of Provincial Grant of Rs.945.60 million, Rs.335 million must be exclusively utilized for payment of Commutation and Pension liabilities of retired employees.
- ii. The University must ensure completion of 100% solarization of UET Peshawar Main Campus by June-2026.
- iii. Re-appropriation in the budget heads for the FY 2025-26 shall be carried out through statutory forum i.e. F&PC and Syndicate.
