In pursuance of Government of Khyber Pakhtunkhwa, Administration Department (Cabinet Wing) Notification No.SO(E&AD)13-/2025 dated 9.3.2026 and Higher Education Department Notification No.SOG/HED/1-12/Gen/2025-26 dated 10.03.2026 read with Higher Education Commission, Islamabad letter No.10-01/2026/Coord/HEC/188 dated 10.03.2026, regarding implementation of *Austerity and fuel conservation measures*, it is hereby notified for the information that the University of Engineering & Technology, Peshawar and its Satellite Campuses shall ensure the following austerity measures:-

1. The University and its satellite campuses shall observe a four day workweek (Monday – Thursday). Necessary staff will attend the duty as per duty roster prepared by their department/section. The Registrar office shall ensure compliance of the duty roster.
2. All the academic activities/classes will be shifted to the online mode. The modalities and operational guidelines for the conduct of online classes shall be devised and communicated to all teaching departments for strict compliance.
3. The Friday classes shall be suitably adjusted and notified by the respective departments to ensure completion of the prescribed credit hours in accordance with the academic requirements.
4. All examinations, tests & interviews shall be conducted as per the notified schedule and in the physical mode.
5. Fuel entitlement of official vehicles is reduced by 25% with immediate effect, and fuel allocations shall be revised accordingly.
6. The use of generators is completely banned with immediate effect.
7. All official meetings, seminars, workshops and conferences shall be arranged and conducted virtually as far as practicable.
8. Assistant Transport Officer shall restrict non-essential movement of vehicles, except emergency purposes.
9. Inter-district official travel shall be minimized and replaced with virtual coordination where possible.
10. Procurement of non-essential furniture, fixtures and equipment shall remain restricted with immediate effect till further orders.
11. Official dinners and receptions shall remain suspended with immediate effect till further orders.

The above mentioned directives shall be implemented in true letter and spirit.
